 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships
 - d. "including" is understood to mean "including without limitation"
 - e. reference to any statutory provision includes any modification or amendment of it
 - f. the headings and sub-headings do not form part of this privacy policy

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Gulab Sorkh Foundation and users with respect to this website. It does not extend to any websites that can be accessed from this website including, but not limited to, any links we may provide to social media websites.

Data that is given to us by you

Data that is collected automatically

Who we share Data with

Keeping Data secure

Data retention

Your rights

- 16. You have the following rights in relation to your data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive."
